Subject: - Approval cum Sanction letter for infrastructure in terms of power supply, water supply, safety equipments, fume hood, laboratory working table and upgrading of laboratory etc in Science Departments of "Colleges with Potential for Excellence" – Release of grant for the year 2008-2009, under the scheme of promotion of Basic Scientific Research.

Sir,

The University Grants Commission has decided to allocate a grant of Rs. 84,00,000/- (Rupees Eighty Four Lakhs Only) to your college @ Rs. 6 Lakhs each to each Science Department indicated below for strengthening of infrastructure in terms of power supply, water supply, safety equipments, fume hoods, laboratories working tables and upgrading of laboratory.

I am accordingly directed to convey the sanction of the University Grants Commission for payment of **Rs. 84,00,000/- (Rupees Eighty Four Lakhs Only) @ Rs.6.00 Lakhs (Rupees Six Lakhs Only)** each to each Science Department Indicated above to the **Principal, Yeshwant Mahavidyalaya, Nanded-431602 (Maharashtra)** for the expenditure to be incurred during the year 2008-2009 as per details given below:-

2. The sanctioned amount is debitable to the major Head 1 A iii) e) and is valid for payment during the financial year 2008-09 only.
3. The amount of the grant shall be drawn by the Deputy Secretary (Drawing and Disbursing Officer), University Grants Commission on the Grants-in-aid bill and shall be disbursed to and credited to the **Principal, Yeshwant Mahavidyalaya, Nanded-431602 (Maharashtra)** through Cheque / Demand Draft/Mail Transfer.
4. The Grant is subject to the Adjustment on the basis of Utilization Certificate in the prescribed proforma submitted by the University/ Colleges/Institution.
5. **IMPORTANT NOTE:**
 - (i) **The second installment grant cannot be used for :-**
 - (a) **repair of toilets** (b) **repair of faculty rooms** (c) **meeting recurrent expenditures like telephone charges for internet connectivity, and other consumables for meeting day-by-day functioning of the department** (d) **water facilities for the department.** The present instalment is to be exclusively devoted for augmenting teaching-learning requirements and Upgradation of laboratory and research infrastructure.
 - (ii) **Out of the grants received, the university departments and the colleges can utilize upto 5% of the grants now released for offering students/projects during the course period to be selected on a merit based defined process. To motivate the research culture among students ,selected students could be provided with a "Project Grant" of Rs.3,000/- per student and a stipend of Rs.2,000/- per student. The period of such project shall be 6-8 weeks.**
6. The University/College/Institute shall maintain proper accounts of the expenditure out of the Grants which shall be utilized only on approved item of expenditure.
7. The Utilization Certificate to the effect that the grant has been utilized for the purpose for which it has been sanctioned shall be furnished to the University Grants Commission as early as possible after the close of the current financial year.
8. The assets, acquired wholly or substantially out of University Grants Commission Grant Shall not be disposed or encumbered or utilized for the purposes other than those for which the Grant was given, without proper sanction of the University Grants Commission and should, at any time the college ceased to function, such assets shall revert to the University Grants Commission.
9. A register of Assets acquired wholly or substantially out of the Grants shall be maintained by the University /College/Institute in the prescribed form.
10. The grantee institution shall ensure the Utilization of grants-in-aid for which it is being sanctioned/paid. In case of non-utilization/part utilization, the simple interest @ 10% per annum or as amended from time to time on unutilized amount from the date of drawing to the date of refund as per provisions contained in General Financial Rules of Govt. of India will be charged.
11. The interest earned by the University/College/Institute on this grants in aid shall be treated as additional grant and may be shown in the U.C. / Statement of Expenditure to be furnished by grantee institution.
12. The University/College/Institute shall follow strictly all the instructions issued by the Govt. of India from time to time with regard to reservation of posts for Scheduled Castes/Scheduled Tribes/OBC/PH etc.

13. The University/College shall fully implement the Official Language Policy of Union Govt. and comply with the Official Language Act, 1963 and Official Languages (Use for Official Purposes of the Union) Rules, 1978 etc.
14. The sanction issues in exercise of the delegation of powers vide Commission Office Order No.25/92 dated May 01, 1992.
15. The funds to the extent are available under the Scheme.
